The Board of Commissioners, County of Jefferson, State of Ohio, received the following email:

John Papik & Kyle Sands from Epic Engineering were at the Justice Center with Bob DiFonzo today. I wanted to summarize where things stand and give a heads up on 2 critical items.

Cooling Tower: The cooling tower for the facility has been compromised (per on site conversation with Bob DiFonzo) due to deterioration of the metal elements which render it non-functional. Given the condition of the tower, the facility would be without cooling for the summer. The facility will need a temporary cooling tower this summer. It will likely need to be located at grade and will also require extensive piping and pumps to address the fact the chillers which are located on the 6the floor. It is unlikely that a temporary cooling tower can be located on the roof of the facility without structural reinforcements. If the Commissioners would like us to develop a standalone bid package for the permanent replacement of the existing cooling tower, we would need approximately 3-4 weeks to put the documents together. We anticipate an 8-12 week fabrication time (we are currently verifying) for the tower plus time for delivery and installation. We can also assist in writing an RFP for a temporary (design/build)Cooling Tower in a shorter timeline if you would like.

Control Systems: The Justice Center currently has no access to the building's HVAC control systems as they do not have the password to access the control computer. We understand that the County staff are attempting to recover the password. To assist we can do initial inquiries from the original installer/manufacturer to learn if there might be a master password (backdoor) to allow access to the system. The system may not be supported by anyone and thus, without the password, remain inaccessible. Access to the computer is critical to gain full control of the system as well as to allow us to fully evaluate the existing systems.

Later this week we will be providing a recommendation with respect to maintenance/upgrades of the existing mechanical systems for consideration by the County. Again, the 2 items above must be addressed in the short term
